**COMMENCEMENT OF PHYSICAL HEARING IN THE HIGH COURT OF
GUJARAT & DISTRICT JUDICIARY IN THE STATE**

Considering the current statistics of cases of Covid-19 in the State of Gujarat, the Hon'ble the Chief Justice, in consultation with the Monitoring Committees for High Court and District Judiciary in the State, has been pleased to pass the following directions with respect to commencement of physical hearing in the Hon'ble High Court of Gujarat & District Judiciary of the State as under:

1. The Hon'ble High Court of Gujarat will commence physical hearing w.e.f. 21/02/2022.
2. The District Courts, as per Annexure-'A', will commence physical hearing w.e.f. 14/02/2022 subject to the existing Standard Operating Procedure.
3. All the District Courts will commence regular physical hearing w.e.f. 21/02/2022.
