ORDER

- 1. Taking note of the news item, which was published in the newspapers on May 24, 2022, from where it was evident that without any protective gears, open drains were being cleaned up by the persons deployed either by the Nagar Nigam or through contractors, notices were directed to be issued to different Authorities in the State.
- 2. When the case was taken up for hearing, Mr. Manish Goel, learned Additional Advocate General submitted that a roadmap shall be prepared for taking care of the situation so that the entire process of cleaning of drains is complete before the onset of monsoon, taking all protections.

certain photographs along with the instructions received from the Nagar

Nigam. The kind of situation, as is evident from the photographs, cannot

be expected in the 21st century.

4. Mr. Trivedi, Senior Advocate sought certain time to have further

instructions to apprise the Court as to what steps shall be taken in this

grave situation, so that lives of the persons, who are involved in the

process of cleaning of drains, are not put at risk. He is also to explain as

to why the machines are not being used for cleaning of the drains

wherever possible, as from number of photographs, it is evident that the

open drains are located near main roads or open spaces, where machines

can easily be used. In some of the photographs, the workers are in about

chest-deep water, loaded with filth in a drain, without using any

protective gear.

5. In view of the urgency of the matter, we direct the listing of the

present petition at 2 P.M. today.
